- Chair Report– Jheren Svoboda
  - Challenging season to say the least but pretty happy with the way everyone is working together on and off the hill. Glad to see decisions being made to benefit the athletes.
- Club Round Table UPDATES
  - o AVST Nice YSL race, first of the season. Barely enough snow, but made it work. Boda came the night before to help get set, so it was a huge help. Snow pack is dwindling. Arctic Valley Cup is slated for the 15<sup>th</sup>/16<sup>th</sup>, but will delay the cup to March 22/23<sup>rd</sup>. SL in the am and GS in the PM. Sunday the 23<sup>rd</sup>. Boda, Kevin and Luke were discussing to host State Champs on March 22<sup>nd</sup>.
  - O ASC Hosting a lot of events these last few weeks. Challenging winter to say the least. Alyeska Resort has been amazing and flexible, very appreciative. Deep in freeride comp. Had to postpone the event yesterday, but pulled it off today. Speed series starts on Tuesday. Clearing venue with resort Friday. Thank you to everyone for rolling with the punches.
  - HART SkiCross this weekend at Hilltop. Lots of working together on training space. Shout out to Bucky and Sparky for pulling off the FISU races. Heard lots of good things. Appreciate the speed races going off next week. Looking forward to it.
  - JSC Warm and rainy, unfortunately. No freeride comp, moving YSL
    State Champs, the GS and SL. Operating on a day by day basis at this point. Tough season. 5 athletes coming up for the Super G. Looking grim.

- UAA Note from Sparky thank you to all the coaches and volunteers.
  Everyone was so incredible. Race series was a huge success!
- Official's Report Julie-Pierre Leclerc/ Brian Hartman
  - o Certified a new REF (Boda) in the last month. Congrats!
  - o Following up with Juneau to see about Homologations. Julie will keep this on her radar.
  - Couple people need to do their Ref follow in fall. Any shadowing at Arctic Valley Cup would be great. U12/U14 State Champs is another shadow opportunity.
  - Bucky with a level 300 they can have 2 shadows, so we can do as much as 3 at a time shadowing.
- Finance Update Mary Thomas
  - Working to get an additional account for YSL only funds so those can be managed to stay with YSL.
  - Wells Fargo not ideal since we know AK Airlines card would be better, need to just go with Wells Fargo to get a credit card.
  - The DNO insurance that was voted on, but it was an \$850 premium, just making sure that is reasonable within our budget.
- Coaches Working Group update Conor Lynch
  - o outcome of meeting 2/23/25:
    - Debriefs after every race is good. Doesn't let things build that don't need to. Been working great.
    - Recap of Alyeska Cup: saw U14s competing with U16s. Is a U16/U18 qualifier – so need to make sure we are not hindering field size or tracks, etc.
    - Schedule is continuing to be challenging for younger athletes. Make sure there are warmups and good inspections. 1 race vs. 2 races.
    - Always trying to find the balance of racing and training.
    - Eaglecrest and snow conditions are not good right now. Everyone wants to always keep Eaglecrest as an option to travel instate.
    - Speed Races: set to having the races with the original schedule. But also talked about moving the venue.
    - Summer Camp training at Alyeska
    - U14s contingency plan #2: If we lose the Super Gs, should meet back up to decide if we are going to go best 5 tech events of 6, or just leave at best 4 tech events. Meet in person to confirm this 2<sup>nd</sup> backup plan the day of the Super Gs if they don't go off.
    - U14 qualifications contingency plan #1: Missed Juneau, and had Arctic Valley and Coke Cola SL, but since Arctic Valley was too close to cutoff, so went with Coke SL and BEST GS Run across the board.

  - Might work well to have both events at Arctic Valley on March 22. We can be flexible with venue, and Hilltop can be a back up venue.
  - YSL race on March 1 is at Alyeska. Bibs and medals are with Bucky. Lower mountain is super sugary right now. Hoping they get some moisture to help. ASC can help with some salt.

  - o Looking at end of April for Coaches 100 & 200.
  - Action Item: Tasha talk to Jen and discuss snow conditions. Will we have snow end of April?
